- 2. Accept resignation of Rob Teal, ACC Chair effective 9/14/2025. Appoint interim ACC chair [action item] Margi motions to accept, Tania seconds. Amy motions to appoint Tate Morris, at-large ACC member, as interim chair if he is willing to accept and Chris Andrus as at-large member of ACC. Margi seconds, all in favor. Amy will serve as interim chair until such time as Tate feels prepared to take over.
- 3. Board Documents for Review- ACC requests from Lot 225 and unapproved construction
 - A. Approved ACC request for pool with drainage plan, fence extension, and driveway extension May 11, 2025
 - B. Communications from property owner to ACC chair from April 30, 2025 through September 5, 2025
 - C. ACC letter to Lot 225 for unauthorized and unapproved improvements (metal-roofed gazebo, putting green, lighting) discussed at board meeting August 25, 2025, reviewed by board members and approved via email September 2-5, 2025. Mailed to resident September 9, 2025
 - D. Receipt of documents from homeowner to ACC Chair prior to receipt of ACC letter
- 4. Review challenges of board policies submitted by owner of Lot 225
 - A. Challenge of late fees and interest calculation response- Sep. 4
 - 1. Board responded with late fee policy, resident again challenged board policy to apply a late fee every month that assessments are not paid and cited legal cases
 - 2. Request for review of late fee policy submitted to attorney Sep. 8
 - 3. Board and Bookkeeper opinion: Articles of Incorporation provide board power to impose charges for late payments and fines. (Article 14.s)
 - B. Challenge of pond access behind pond lot residences- Sep. 8

- C. Challenge of misuse of fees for pond lot repairs and demand for financial records related to bank repairs (30 day request)- Sep. 8
- D. Challenge of board's right to adopt and implement policies (allowing for composite lots, enforcing parking, altering assessments and late fees, signs restricting access behind pond lots) -Sep. 10
- E. Challenge of ACC fine applied to account- Sep. 12
- F. Challenge of lien authority for overdue fees from fines- Sep. 12
- G. Demand for records of ACC members voting records- Sep. 12
- H. Demand for access to records within 30 days- Sep. 8th
- I. Demand for access to records within 15 days- Sep. 12
- J. Challenge of placement of boulders in common area- Sep. 13
- K. Demand to keep his name and email requests confidential
